PHAS Score

COVID-19 update

Mr. Pike, in collaboration with senior leadership staff, put in place several precautions to assist staff and clients during the COVID-19 situation. Supervisors conducted analyses to determine work-from-home eligibility for their direct reports. Staff will move toward conducting appointments over the phone and via email. Cleaning products and sanitizing agents have been made available at all properties, and the front lobby is sanitized every 90 minutes. Maintenance will respond to emergency work orders only, use gloves before entering the unit and during the visit, and encourage tenants to self-perform maintenance.
